Admission to plus one course in the state through Single Window System was officially closed on 25th August 2023.

As per reference 3rd cited, Tribal development officer reported that Anitha P is from Koraga got admission in BEM HSS, Kasargod in Science. This student needs Course change to Humanities (Course Code 11) in same school, as special case stipulated in the request.
